# A NOTE FROM YOUR TREASURER

Hello, everyone! I hope you're having a great start to your year.

## A few housekeeping items for those of you who will be having students participate in festivals:

- Please try to get your registration checks to your hosts as soon as possible. Some of your school's checks have a 60-day window in which we can cash it, and if those 60 days expire there will be much more leg work for both you and the hosts to get the check reprinted (not to mention the bank fee!). Snail mail can take a while, and we don't want the 60-day window to close on us!
- If your school registration payment has not been received by the host by the start of the festival, be prepared to pay for the registration yourself so that your student(s) can participate. That payment will be held as a "placeholder" until the check arrives, or you can have your district to reimburse you directly and we will use your check as the registration payment.
- Be sure that your business offices know to make the check out to PMEA or PMEA District 1 and to mail it to the hosts. Do NOT have the business offices mail directly to PMEA or to me (the treasurer)!



## A few reminders for hosts:

- Please remember to send registration checks in batches either weekly or biweekly, along with a completed deposit slip. See the above note for further details.
- Double check what participation fees and insurance are required for your festival, based on the number of days and type of festival it is.
- Be diligent and timely with your paperwork submissions, and be sure to use the forms that Steph and Rachel provided at the beginning of the school year. Old forms – even ones from last year! – may have been revised.
- Remember that your guest conductor and accompanist checks won't be cut until the contract, W9, AND payment request are completed. The check printing and mailing time could take a few weeks, so put in for it sooner rather than later!
- I am a huge fan of emailed submissions of paperwork! They're faster and easier to track. Document/camera scanners on your phone permit you to send things in a jiffy, and without incurring postage costs!
- Thank you so much to the amazing hosts this year and in years past who have made our festivals and fests a success because of their time, dedication, and hard work! Let's make some more great music this year!!

# PASSING THE COMMUNICATIONS TORCH

"Sure, I can help." How do you resist the bottom lip quiver of Areta Kalogeras when she asks you to do something? That's how this all started in the fall of 2006 when I came into her office for our daily lunch period together. Our favorite spokesperson for retired members and conference photographer, Paul Fox, had just announced he was retiring from the THREE positions he held on the District 1 EXCOM for decades: secretary, treasurer, and editor. Areta replaced him with 3 people on the EXCOM. I didn't know at the time this would turn into an 11+ year journey through technological challenges and advances, as well as six District 1 presidents!



It's amazing to think of how different communication was back then. We sent out a printed newsletter through the mail twice per year (don't get me started about how to deal with printers, bulk mailing, postage, and mailing services – Steve Leopold and I could tell you stories!), did actual paper ballot elections at festival director's meetings with announcements of winners in the newsletter; the website was this "thing" that we thought we could use, but didn't do much, and the most we did with email was share membership updates like job postings and workshop flyers (thanks to Kevin McElheny). Paul gave me a box full of newsletter archives and a stack of floppy disks with newsletter files saved in WordPerfect (remember that program?!).

Some of you will remember that in those first few years, I only had the ability to update the website on one machine at school or on my home computer, because we were maintaining the site in the now defunct and obsolete program Microsoft FrontPage. We've come a long way since then, thanks to smart phones, apps, online content management systems like Weebly, and social media. This past year, due to weather concerns, several festivals were cut short, but they were able to live stream concerts early in the day so folks could still hear and see the groups perform. A few tweets and Facebook posts with the link allowed parents to watch their students from their workplace computers or phones. The EXCOM does most everything through shared Google folders, docs, sheets, etc, that can be worked on collaboratively without trying to remember "which version" was the correct one sent out. We hold online elections and registration for workshops, use the website for pretty much everything (especially posting audition results!), and do an electronic newsletter with embedded links in the PDF. Notification of upcoming events, special announcements, job opportunities, and more are posted on social media, and major membership announcements and information are sent out directly from the state via email to the most updated contact information they have on file.

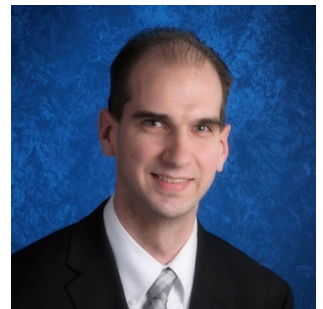

## GETTING FEDERAL FUNDS FOR YOUR MUSIC PROGRAM

Now is the time for you to have discussion with music education colleagues in your school district and your administrators about how to access federal education funding for your music program.

As a reminder, the Every Student Succeeds Act (ESSA) creates a new funding stream that is designed to ensure a "well-rounded" education for all students. Under ESSA, music and the arts are designated as well-rounded subjects. These new federal funds, known as Title IV, Part A or Student Support and Academic Enrichment Grants (SSAEG), will flow through the Pennsylvania Department of Education (PDE) to school districts.



The process will vary from district to district, so you may have to ask some questions to find out how your district handles these requests – but I promise it can be worth it to do a little bit of research in the long run.

You may want to start by talking to your building principal and explain that you'd like to be involved in the process to use these funds for the music program. You'll likely be directed to the person in your district that handles all of the federal and state forms and grants. They may be appreciative of you coming to them since the law requires educator and community input into the use of these funds.

You can start the process by visiting [pmea.net](http://pmea.net) and navigate to the Advocacy Focus Area where you'll find two resources specifically about Title IV funds:

- a) **A document from January 2018 explaining the process school districts follow to access federal funds**
- b) **A presentation from the 2018 PMEA Summer Conference showing you how to talk to administrators to ask for these funds**

Here is a list of some suggested uses of Title IV funds for music education:

- a) **Musical instruments**
- b) **Sheet music**
- c) **General music supplies/text books**
- d) **Performance space upgrades**
- e) **Music technology (computers, tablets, software)**
- f) **Curriculum materials**
- g) **Content area specific professional development**
- h) **Additional music courses (adding a piano or guitar class)**
- i) **Music related field trip**

NAfME and PMEA has advocated and worked at the federal and state level to ensure this funding stream is available and accessible for music and the arts. The way we can sustain this funding is knowing that schools are using the money effectively. So, please take some time and find out how to access these funds in your district. And, as you find successes or bumps in the road, please keep us informed so we can continue to improve our advocacy work for these funds.

I'll be presenting a session about these federal funds and how to access them at the District 1 Professional Development Day on November 20<sup>th</sup>. I promise it won't be too much policy speak and I'll help make the process as simple as possible for you! ## ADVOCACY CORNER

### PULL-OUT LESSONS VS. SPECIALIZED MUSIC INSTRUCTION: THE POWER OF LANGUAGE

In a conversation with a colleague recently, I used the phrase "Specialized Music Instruction" when talking about instrumental music. I could tell by their expression—they had no idea what I was speaking of. We began having a conversation about why our school district now calls our lessons Specialized Music Instruction instead of "pull-out lessons." The National Association for Music Education (NAfME) has also endorsed this title, noting, "[their position statement] uses the term "specialized music instruction" rather than "pullout," a word that can perpetuate the bias against comprehensive schooling."

Our conversation grew into one that spoke of how language communicates value. "Pull-out" seems optional. Specialized instruction sounds like something that is right for children. This year, I encourage you to advocate for your students' learning by referring to "pull-out lessons" as "Specialized Music Instruction."

In his book *Cultures of Thinking*, Ron Ritchhart discusses eight cultural forces that will transform our schools. One of those forces is language; and within language, there are seven intentional ways we can use language to create cultures of thinking (to two of which I have added bold emphasis):

#### The Language of Community (vs. Distance)

- Pronoun choice can communicate a sense of inclusiveness, collaboration, and community (we, us, our); or it can deliver a message of division, separateness, and control (I and you)

#### Language of Identity

- These words communicate that it is learning to do and act authentically that matters, not just learning about the subject.

Language of Personal Agency (vs. Rescuing)

Language of Noticing & Naming

Language of Knowing (Conditional versus the Absolute)

Language of Feedback & Praise

Language of Listening

Our use of language impacts community and identify. Richhart hits the nail on the head by saying, "These words communicate that it is learning to do and act authentically that matters, not just learning about the subject." So, the big question is, how does Ritchhart's connect to advocacy and music education?

In May of this year, PMEA District 1 sent out a survey to membership to get a picture of how instrumental music instruction is being delivered. With 91 respondents, we now see the wide array of programming happening across the five counties that span our district. As you review the data and read the qualitative feedback, you will notice trends, things to celebrate, and areas of concern. You may want to see where your program fits in with the results. Do you see ways other programs offer instrumental music that you could offer in your program or use this data to make a case for a change with your administrators? My challenge to you, is to turn this data into information, and refer to Richhart's research on language to help you determine your next steps. Our hope is for this data to be useful and actionable.

Thank you to Cory Neville (Quaker Valley School District) for helping to spearhead this project. Data like this is extremely important, as we can speak to regional trends and practices as we advocate for what is best for our students.

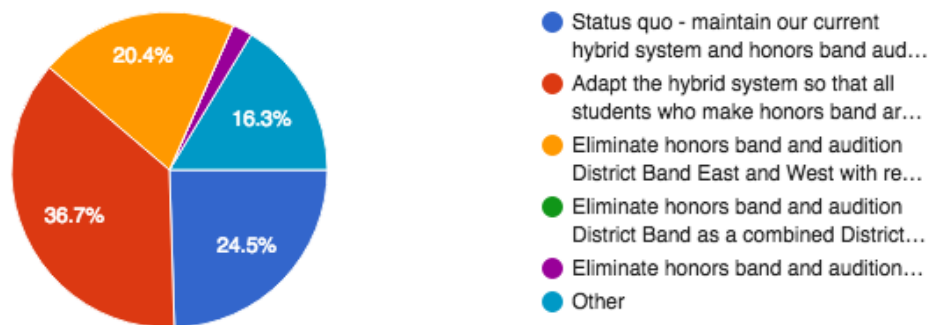
# HONORS BAND SURVEY RESULTS

During this past festival season, a survey was sent out to our PMEA District 1 Band membership regarding the structure and schedule of Honors Band. Below are the results of the survey:

1. 70% of our D1 membership believes we need to change the current system regarding Honors & District Band.

49 responses

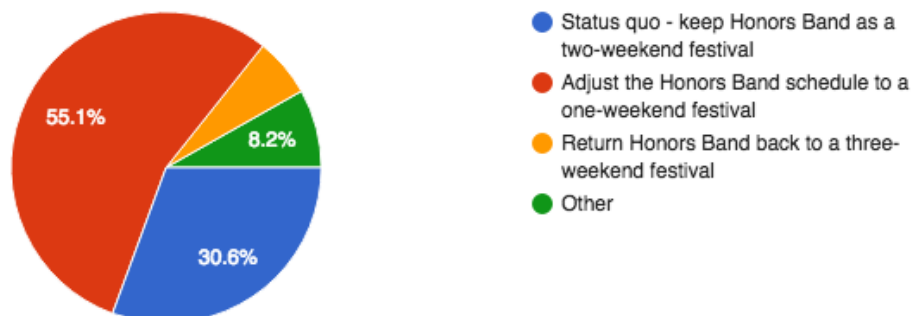


- (**Dark Blue** - Status quo- maintain our current hybrid system and honors band audition process)  
(**Red** - Adapt the hybrid system so that all students who make honors band are auto-bids into District Band East & West)  
(**Orange** - Eliminate honors band and audition District Band East and West with representation)  
(**Green** - Eliminate honors band and audition District Band as a combined District with representation)  
(**Purple** - Eliminate honors band and audition District Band without representation)  
(**Light Blue** - Other)

# AUDITION MUSIC LISTS

## What to Prepare and When

### HONORS JAZZ FESTIVAL

#### Improvisation –

All students will improvise for a minimum of two choruses over the Jamey Aebersold Vol. 2 “Nothing But the Blues”, Track 5 Fast Bb Blues

#### Lead Trumpet –

The following should be prepared in addition to the “Jazz Conception” etude

- Hayburner from the Basie-Nestico Lead Trumpet Book published by Kendor Music
- Begin 5 measures before letter G and end at letter I

#### Etudes –

All instrumentalists will play the following etude from the Jim Snidero “Jazz Conception” book

- Alto, Tenor and Bari Sax; Trumpet and Trombones – **Friends** (*bass trombone should use the bass trombone book*)
- Piano and Vibes – **Friends** (*from the regular book; NOT THE COMPING BOOK*)

Written part for Intro and Chorus 1 and comp for chord changes provided for Chorus 2

- Guitar – **Friends**

Written part for Intro and Chorus 1 and comp for chord changes provided for Chorus 2

- Bass – **Friends** (*from the “Bass Lines” book*)

Written bass line for Intro and Chorus 1 and improvise a bass line for chord changes provided for Chorus 2

- Drums – **Friends**

Written out drum part for Intro and Chorus 1 and the lead sheet for Chorus 2

(treat Chorus 2 as if it is a big band chart; setting up figures and playing fills as the music dictates)

Demonstrate styles including but not limited to the following:

Swing, Samba, Mambo, Bossa Nova, Salsa, Cha-Cha, Afro-Cuban, Funk

Trade fours repeatedly (four bars of time and fours bars of solo fills) with any of the previously mentioned Jazz styles

### AUDITION PLACEMENT PROCEDURES FOR HONORS JAZZ FESTIVAL

**TRUMPET PLACEMENT:** Five trumpets will be selected for each Band. The 5<sup>th</sup> trumpet will double the Tpt IV part and or any trumpet part at the discretion of the Guest Conductor.

Second highest scoring Lead trumpet	Band 2	Tpt 1
Highest scoring trumpet (non-lead)	Band 1	Tpt 2
Second highest scoring trumpet (non-lead)	Band 2	Tpt 2
Third highest scoring trumpet	Band 1	Tpt 3
Fourth highest scoring trumpet	Band 2	Tpt 3
Fifth highest scoring trumpet	Band 1	Tpt 4
Sixth highest scoring trumpet	Band 2	Tpt 4
Seventh highest scoring trumpet	Band 1	Tpt 5
Eighth highest scoring trumpet	Band 2	Tpt 5

For all remaining sections the following procedure will be followed:

Fourth Highest scoring Alto Sax	Band 2	Chair 2

Same procedure will be followed for trombones\* and rhythm sections.

\* In the absence of a Bass trombone audition, the fourth trombone book will be taken in regular order.

Selection of vibe, piano, guitar and bass for each band based upon recommendation of the audition committee.



## PIANO ACCOMPANIST FOR DISTRICT CHORUS

Pre-requisite: Student auditioning must be an accompanist at their high school or be a full-time participant in their high school choral program for one of the choirs.

1. All students must pay the required \$5 audition fee.
2. Student should be prepared to play open score on both choral audition pieces for District Chorus Auditions. Students will be asked to play up to two vocal lines on two staves in one or more of the following combinations: S/A, T/B, S/T, A/B, etc. Please refer to the District Chorus audition procedures for the correct music.
3. Student should prepare the following accompaniment in the year of:
  - Cycle 2 (2018-19) – And He Shall Purify from The Messiah by Handel

  - Cycle 4 (2020-21) – Hallelujah from The Mount of Olives by Ludwig Van Beethoven,  
G. Schirmer, Inc. 50293600
  - Cycle 1 (2021-22) – The Last Words of David by Randall Thompson, E.C. Schirmer Music Co. 2294
4. Students auditioning will be given time to warm-up to adjust to the instrument.
5. Students may be asked to play accompaniments to basic vocal warm-ups.
6. Students may be asked to play major or minor scales.
7. Students may be asked to sight-read a Bach chorale on the grand staff.
8. Student will audition for 3 judges and the festival conductor or collegiate choral director who will determine if the student is qualified to accompany the choir. The student will be scored by the judges in conjunction with the festival conductor or other qualified director input. District 1 is under no obligation to select an accompanist if no one meets the qualifications to accompany in the judges' opinion. (If possible, one of the judges will be the qualified adult mentor/accompanist). A maximum of two students may be chosen.
9. The accompanist will not count as a schools' representation.
10. Students who are selected to accompany District Chorus will be expected to audition on piano for Region Chorus on the District Chorus repertoire at auditions. This committee should include the guest conductor so that he/she may suggest which student accompanist should play which piece at the District Chorus Festival. Students will have to play an accompaniment and an open score (of no more than four parts over four staves) from the folder. They will audition for three judges. The top scoring student will move on to the Region level if Region Chorus is accepting student accompanists.
11. Student Accompanists will be permitted to sing, when not playing, at all the choral festivals up to and including All-State Chorus.
12. Student accompanists may choose to audition as a singer through the festival audition procedures. This will be important for those accompanists who apply to play at the All-State Festival but are not selected, or if Region Chorus is not accepting student accompanists.
13. An adult mentor/accompanist may be assigned to play for parts of the concert, and students may only be asked to play part of the concert. The mentoring accompanist will work with the guest conductor and the judging committee to assign accompanist responsibility for concert repertoire. If any of the student selections are not adequately prepared, the mentoring accompanist will take over and the student may not be permitted to move to the next level.
14. Directors who have students auditioning should avoid serving as a judge for the accompanist auditions for that year.

## NEW DISTRICT CHORUS AUDITION PROCEDURES BEGIN IN 2018

Over the past several years, there has been considerable discussion at District Chorus festival director meetings regarding how best to run auditions. A committee was created and charged with the task of researching procedures from other PMEA districts as well as other states. The committee's recommendations were brought before the directors at the 2018 District Chorus festival, discussed, and ultimately voted upon to begin implementation with the 2018-19 school year. The most significant changes are that there will now be TWO audition selections (one lyrical, and one technical) and a sight-reading component (a 4-bar excerpt in stepwise motion that has a minimal impact on the overall score). Audition selections are listed in the table on the next page.

### General Information

- a) Audition host school site should be centrally located in PMEA District 1.
- b) Photocopied music is not permissible by law.
- c) The auditions will be held the Monday before Thanksgiving.
- d) The auditions will include two selections each year in a cyclical order as stated in the PMEA District 1 Newsletter and on the PMEA District 1 Website and sight-reading.
- e) Audition pieces will be included in the concert program for District Chorus.
- f) Every school must bring a minimum of two different voice parts. The district president may grant an exemption to this policy.
- g) Each school represented at the auditions will be guaranteed one student in the district chorus if they choose
